This letter is in response to the Court's order that the Receivership Entities shall file with the Court and serve upon the Receiver and the Commission a sworn statement listing (a) the identity, location and estimated value of all Receivership Property; (b) all employees (and job descriptions thereof), other personnel, attorney, accountants and any other agents or contractors of the Receivership Entities and (c) the names, addresses and amounts of claims of all known creditors of the Receivership Entities.

I and my staff continue to examine the books and records of the Receivership Entities. We have extremely limited information relating to the ABFP, Fidelis and Retirement Evolution entities.
