undersigned counsel, hereby file this Joint Motion for Approval of Stipulation Regarding Email Production and for Cancellation of Discovery Hearing Scheduled for March 15, 2021 (the "Joint Motion"), and state:

- 1. On March 1, 2021, Magistrate Judge Bruce E. Reinhart conducted a discovery hearing (the "Discovery Hearing") concerning a dispute between the Receiver and McElhone regarding the Receiver's production of emails in response to McElhone's various document requests (the "Discovery Dispute"). *See* ECF No. 495, Paperless Order Setting Discovery Hearing.
- 2. On February 27, 2021, the Receiver and McElhone filed a Joint Discovery Memorandum Regarding Hearing Scheduled for March 1, 2021 (the "Joint Memo") (ECF No. 497). As detailed in the Joint Memo, the Discovery Dispute was focused on the Receiver's production of emails from the mailboxes of seven (7) Par Funding custodians, five (5) of which have been "initially processed" (Joseph LaForte, Lisa McElhone, Jamie McElhone, Joseph Cole Barleta, and Ben Mannes) and two (2) of which are unprocessed (Victoria Villarose and Wendy Furman) (collectively, the "Requested Emails").
- 3. The Receiver raised concerns about the burden and cost to the receivership estate to process and produce the Requested Emails, and concerns relating to the production of the Requested Emails in native format (and suggested that McElhone and the other Defendants should provide the Receiver with search terms for identifying potentially relevant emails from within the mailboxes of the Requested Emails).
- 4. McElhone, on the other hand, indicated that the Requested Emails were likely to contain information that was critical to the defense of this case, and requested the entire email accounts from these custodians so that she and the other Defendants could use "Continuous Active Learning AI technologies" and other analytics to review and identify potentially relevant emails.

- 5. Following the Discovery Hearing, counsel for the Receiver and counsel for McElhone engaged in several meet-and-confer discussions to resolve the Discovery Dispute. The parties have now reached agreement on a process by which the Receiver will process the native MBOX files for Victoria Villarose and Wendy Furman, at McElhone's expense. The Receiver's eDiscovery vendor has already begun the initially processing of these two accounts in anticipation of this signed stipulation. The Receiver will provide the processed files from all seven (7) custodians that comprise the Requested Emails in load file format (the "Processed Files"), which will be loaded into McElhone's eDiscovery vendor, PLSDATA, LLC's ("PLS") Iconnect database software. The Defendants and their counsel will be allowed access to review the Processed Files, but the database will be set to prevent the Defendants from downloading native files. The Defendants and their counsel will be able to print/download files from this database, but PLS will institute processes to ensure that any printed/downloaded files contain control numbers and confidentiality designations stamped on the documents.
- 6. The owner of PLS, Marc Hirschfeld has agreed that he will not provide access to the eDiscovery database where the Processed Files are being hosted to anyone not bound by the terms of the Protective Order (ECF No. 437), and Marc Hirschfeld and PLS agrees to be bound to the terms and conditions of the Protective Order (ECF 437). Additionally, Mr. Hirschfeld, McElhone, and the other Defendants who are provided access to the eDiscovery database where the Processed Files will be hosted will return or destroy the Requested Emails and any other "Protected Material" upon the final disposition of this action, pursuant to the requirements of Paragraph 14 of the Protective Order.
- 7. A stipulation setting forth this process for the production of the Requested Emails is attached as Exhibit 1 (the "Stipulation").

- 8. On March 4, 2021, the Court entered a Paperless Order (ECF. No 503) setting a continued discovery hearing on the Discovery Dispute for March 15, 2021, at 10:00 A.M. EST (the "Continued Hearing").
- 9. In light of the parties' resolution of the Discovery Dispute, the Receiver and McElhone respectfully request Judge Reinhart to enter an Order approving the Stipulation, retaining jurisdiction to enforce the terms of the Stipulation, if necessary, and canceling the Continued Hearing scheduled for March 15, 2021.
 - 10. A proposed Order granting this Joint Motion is attached as Exhibit 2.

- 1. McElhone has requested that the Receiver produce emails from the mailboxes of seven (7) Par Funding custodians, five (5) of which have been "initially processed" (Joseph LaForte, Lisa McElhone, Jamie McElhone, Joseph Cole Barleta, and Ben Mannes) and two (2) of which are unprocessed (Victoria Villarose and Wendy Furman) (collectively, the "Requested Emails").
- 2. In light of concerns the Receiver has raised relating to the burden and cost to the receivership estate to fully process and produce the Requested Emails, and concerns relating to the production of the Requested Emails in native format, the Receiver and McElhone agree that the Receiver will process the native MBOX files for Victoria Villarose and Wendy Furman, at McElhone's expense, not to exceed the agreed upon price of \$20 per GB for the uncompressed size of the MBOX files. This pricing shall only apply to the processing of the files for these two custodians. The Receiver's eDiscovery vendor has already begun the initially processing of these two accounts in anticipation of this signed stipulation. The Receiver will provide the processed files from all seven (7) custodians that comprise the Requested Emails in load file format (the "Processed Files"), which will be loaded into PLS's Iconnect database software. The Defendants and their counsel will be allowed access to review the Processed Files, but the database will be set to prevent the Defendants from downloading native files. The Defendants and their counsel will be able to print/download files from this database, but PLS will institute processes to ensure that any printed/downloaded files contain control numbers and confidentiality designations stamped on the documents.

- 3. Mr. Hirschfeld, on behalf of himself and PLS, agrees that he will not provide access to the eDiscovery database where the Processed Files are being hosted to anyone not bound by the terms of the Protective Order (ECF No. 437), and Marc Hirschfeld and PLS agrees to be bound to the terms and conditions of the Protective Order (ECF 437).
- 4. Additionally, McElhone and Mr. Hirschfeld agree that McElhone, Mr. Hirschfeld, and the other Defendants who are provided access to the eDiscovery database where the Processed Files will be hosted will return or destroy the Requested Emails and any other "Protected Material" generated from the Requested Emails upon the final disposition of this action, pursuant to the requirements of Paragraph 14 of the Protective Order.
