## NON-PARTIES, ECKERT SEAMANS CHERIN & MELLOT, LLC AND JOHN W. PAUCIULO, NOTICE OF COMPLIANCE WITH COURT ORDER <u>DIRECTING SERVICE OF CONFIDENTIALITY DESIGNATIONS</u>

Non-Parties, Eckert Seamans Cherin & Mellot, LLC ("Eckert Seamans") and John W. Pauciulo ("Mr. Pauciulo") (together, the "Deponents"), submit this Notice of Compliance with this Court's April 23, 2021, order directing the Deponents to provide the SEC with notice of those portions of deposition transcripts they seek to designate as confidential. (ECF No. 555).

On April 28, 2021, Deponents provided SEC counsel with its Confidentiality deposition designations. On April 29, 2021, in response to the SEC's request for additional information, Deponents provided detailed page and line descriptions and further explanations of the reasons for the designations.

As the designations indicate, there are minimal assertions in each transcript (11 total over the 331 pages of Mr. Pauciulo's deposition; 4 total in the 231 pages of the 30(b)(6) deposition). Deponents explained that they asserted confidentiality in good faith on behalf of clients who have not waived privilege out of an abundance of caution and so that they do not run afoul of the law firm's professional responsibilities to those clients. Deponents' counsel has also offered to provide further information when Deponents confer with the SEC today at 3:30pm.

Further, in light of developments this week, including Mr. Vagnozzi apparently waiving his assertion of privilege, Deponents have offered to resume those depositions to answer those questions. As such, Deponents believe most of the privilege challenges are moot.
