- 1. Defendant Dean Vagnozzi has paid the Receiver the sum of \$3,281.00 (the "Pillar 1 Payment") in exchange for the Receiver transferring the general partnership interest in Pillar 1 Life Settlement Fund LP ("Pillar 1") that ABFP Management Company, LLC ("ABFP Management") owns, which the Receiver now controls by virtue of the inclusion of ABFP Management as one of the Receivership Entities.
- 2. Dean Vagnozzi has paid the Receiver the sum of \$2,391.00 (the "Pillar 2 Payment") in exchange for the Receiver transferring the general partnership interest in Pillar 2 Life Settlement Fund LP ("Pillar 2") that ABFP Management Company, LLC ("ABFP Management") owns, which the Receiver now controls by virtue of the inclusion of ABFP Management as one of the Receivership Entities.
- 3. Dean Vagnozzi has paid the Receiver the sum of \$2,163.00 (the "Pillar 3 Payment") in exchange for the Receiver transferring the general partnership interest in Pillar 3 Life Settlement Fund LP ("Pillar 3") that ABFP Management Company, LLC ("ABFP Management") owns, which the Receiver now controls by virtue of the inclusion of ABFP Management as one of the Receivership Entities.
- 4. Dean Vagnozzi has paid the Receiver the sum of \$1,634.00 (the "Pillar 4 Payment") in exchange for the Receiver transferring the general partnership interest in Pillar 4 Life Settlement

Family Trust; Blue Valley Holdings, LLC; LWP North LLC; 500 Fairmount Avenue, LLC; Recruiting and Marketing Resources, Inc.; Contract Financing Solutions, Inc.; Stone Harbor Processing LLC; and LM Property Management LLC; and the Receivership also includes the properties located at 568 Ferndale Lane, Haverford PA 19041; 105 Rebecca Court, Paupack, PA 18451; 107 Quayside Dr., Jupiter FL 33477; 2413 Roma Drive, Philadelphia, PA 19145.

Fund LP ("Pillar 4") that ABFP Management Company, LLC ("ABFP Management") owns, which the Receiver now controls by virtue of the inclusion of ABFP Management as one of the Receivership Entities.

- 5. Defendant Dean Vagnozzi has paid the Receiver the sum of \$1,833.00 (the "Pillar 5 Payment") in exchange for the Receiver transferring the general partnership interest in Pillar 5 Life Settlement Fund LP ("Pillar 5") that ABFP Management Company, LLC ("ABFP Management") owns, which the Receiver now controls by virtue of the inclusion of ABFP Management as one of the Receivership Entities.
- 6. Defendant Dean Vagnozzi has paid the Receiver the sum of \$4,517.00 (the "Pillar 7 Payment") in exchange for the Receiver transferring the general partnership interest in Pillar 7 Life Settlement Fund LP ("Pillar 7") that ABFP Management Company, LLC ("ABFP Management") owns, which the Receiver now controls by virtue of the inclusion of ABFP Management as one of the Receivership Entities.
- 7. The Receiver's general partnership interests in Pillar 1-5 and Pillar 7 each represent 0.1% of the total interests in the investment funds.
 - 8. The Receiver agreed to accept the Payments in Paragraphs 1-6 above.
- 9. The Receiver has reviewed these transactions with his consultant, DSI, and has determined, in his professional judgment, that the Payments in Paragraphs 1-6 above represent the present fair value of the Receiver's general partnership interest in Pillar 1-5 and Pillar 7.
- 10. All provisions of the Court's Order will be satisfied as to Pillar 1-5 and Pillar 7 and, as such, Pillar 1-5 and Pillar 7 shall no longer have any association or involvement with, or coordination or reporting obligations to, the Received and the Receivership Estate.
