**ORDER GRANTING RECEIVER'S TWENTIETH MOTION TO LIFT
LITIGATION INJUNCTION AS TO CERTAIN GARNISHMENT PROCEEDINGS**

THIS CAUSE comes before the Court upon the Receiver's Twentieth Motion to Lift Litigation Injunction as to Certain Garnishment Proceedings [ECF No. 1149] ("Motion"), filed on February 12, 2022.

In the Motion, the Receiver seeks to modify the Court's Amended Order Appointing Receiver dated August 13, 2020 [ECF No. 141], so as to lift the litigation injunction provided for in that Order for certain garnishment matters currently pending in the Court of Common Pleas of Philadelphia County, Pennsylvania to be opened for the limited purpose of authorizing the Receiver, in his discretion, to dissolve current writs of garnishment, to mark judgments satisfied, and/or to reopen confessed judgments, where the counterparty merchant either has resolved, has agreed to resolve prior defaults, or otherwise filed for bankruptcy protection, in certain cases in the Court of Common Pleas of Philadelphia County, Pennsylvania. The Receiver also seeks to lift the litigation injunction to discontinue an appeal of a case in the Superior Court of Pennsylvania.


The Receiver has made a sufficient and proper showing in support of the relief requested. Accordingly, it is hereby

ORDERED AND ADJUDGED that the Receiver's Motion is **GRANTED** with respect to the relief requested. Specifically, the litigation injunction set forth in the Court's Amended Order Appointing Receiver dated August 13, 2020 [ECF No. 141] is hereby lifted in the following matters in the Court of Common Pleas of Philadelphia County, Pennsylvania, and solely for the purposes described in the Motion:

- e. *Complete Business Solutions Group, Inc. v. A+ Hardwood Installations Inc. and James Bruske*, Philadelphia Court of Common Pleas Docket No. 200300983.
- f. *Complete Business Solutions Group, Inc. v. A and S Logistics Oilfield LLC and Leny Munoz*, Philadelphia Court of Common Pleas Docket No. 200701375.

The litigation injunction is also lifted to allow the Receiver to discontinue the appeal in *Complete Business Solutions Group, Inc. v. Barley Forge Brewing Company LLC and Gregory Alan Nylan* before the Pennsylvania Superior Court at Docket No. 655 EDA 2020.
