**RECEIVER, RYAN K. STUMPHAUZER’S MOTION TO LIFT LITIGATION
INJUNCTION AS TO CERTAIN COUNTERPARTIES IN DEFAULT UNDER
AGREEMENTS WITH COMPLETE BUSINESS SOLUTIONS GROUP, INC.,
CAPITAL SOURCE 2000, INC., OR CONTRACT FINANCING SOLUTIONS, INC.**

Ryan K. Stumphauzer, Esq., Court-Appointed Receiver (“Receiver”) of the Receivership Entities,¹ by and through undersigned counsel, hereby files this Motion to Lift Litigation

Injunction as to Certain Counterparties in Default Under Agreements with Complete Business Solutions Group, Inc. (“CBSG”), Capital Source 2000, Inc. (“CS2000”), or Contract Financing Solutions, Inc. (“CFS”), and states as follows:

FACTUAL BACKGROUND AND SUMMARY OF PROPOSED CLAIMS

On or about July 27, 2020, the Court appointed the Receiver as receiver for CBSG and other associated entities.² See Order Appointing Receiver [ECF No. 36]. As stated in the Amended Order Appointing Receiver dated August 13, 2020 [ECF No. 141], the Court appointed the Receiver because:

the appointment of a receiver in this action is necessary and appropriate for the purposes of marshaling and preserving all assets of the Defendants (“Receivership Assets”) and those assets of the Relief Defendant that: (a) are attributable to funds derived from investors or clients of the Defendants; (b) are held in constructive trust for the Defendants; and/or (c) may otherwise be includable as assets of the estates of the Defendants (collectively, “Recoverable Assets”).

Amended Order Appointing Receiver, p. 1.

The Amended Order Appointing Receiver further provides for a stay of all litigation involving the Receiver and the Receivership Entities:

All civil legal proceedings of any nature, including, but not limited to, bankruptcy proceedings, arbitration proceedings, foreclosure actions, default proceedings, or other actions of any nature involving: (a) the Receiver, in his capacity as Receiver; (b) any Receivership Property, wherever located; (c) any of the Receivership Entities, including subsidiaries and partnerships; or, (d) any of the Receivership Entities’ past or present officers, directors, managers, agents, or general or limited partners sued for, or in connection with, any action taken by them while acting in such capacity of any nature, whether as plaintiff, defendant, third-party plaintiff, third-party defendant, or otherwise (such proceedings are hereinafter referred to as “Ancillary Proceedings”)

(the “Litigation Injunction”). [ECF No. 141, ¶ 32.]

The Receiver requests this Court to lift the Litigation Injunction for the limited purpose of allowing the Receiver to execute on existing judgments against certain counterparties in default under agreements with CBSG, CS2000, or CFS. Specifically, the Receiver intends to execute on existing judgments against the following entities (the “Counterparties”) that entered into merchant cash advance agreements with CBSG, CS2000, or CFS (the “Agreements”):

- a. Loy Customs Pool Design LLC;
- b. Paradise Resort Bar and Grill Inc. d/b/a Paradise Resort Bar and Grill;
- c. Diego J. Solorzano Sole Proprietor d/b/a DS Snacks;
- d. Nur Express LLC d/b/a Nur Express;
- e. Kahuna Construction Inc. d/b/a Kahuna Construction;
- f. CFG Transport Corp. d/b/a CFG Transport;
- g. Turncall LLC d/b/a Truncall;
- h. Jackbuilt Contractors LLC d/b/a Jackbuilt Contractors d/b/a JB Industries;
- i. WM Interiors Inc. d/b/a WM Interiors;
- j. Venture Investments Group LLC d/b/a Venture Investments Group;
- k. N. Barlow Construction LLC d/b/a N. Barlow Construction d/b/a S. Barlow Packing & Shipping;
- l. First Street Corporation d/b/a First Street Corp.;
- m. R. March Management d/b/a Electrical Co. d/b/a R.C.M. Electrical Corp.;
- n. American Concrete LLC;
- o. Turf Pros Solution LLC d/b/a Turf Pros Solution d/b/a Turf Solution Pros;
- p. Catalonia Olive Oil Inc. d/b/a Catalonia Olive Oil d/b/a Catalonia Golden Valley d/b/a Catalonia Brands;

- q. Golden Grooming Co. d/b/a Golden Grooming;
- r. Eric J. Hughes Sole Proprietor d/b/a EZY-E's Takeout Delivery;
- s. All Three Shuttle Service Inc. d/b/a All Three Shuttle Service; and
- t. United Medical Supply, Inc. d/b/a United Medical Supply.

The Receiver has determined, in his professional judgment, that it is in the best interests of the Receivership Estate to execute on judgments against these Counterparties, as well as certain of the guarantors under these various Agreements and the collateral and security that any of the Counterparties may have provided to CBSG, CS2000, or CFS under these Agreements.

ARGUMENT

Receivership courts generally rely on a three-factor test to adjudicate requests to lift the litigation stay injunction. These factors include:

(1) whether refusing to lift the stay genuinely preserves the status quo or whether the moving party will suffer substantial injury if not permitted to proceed; (2) the time in the course of the receivership at which the motion for relief from the stay is made; and (3) the merit of the moving party's underlying claim.

S.E.C. v. Byers, 592 F. Supp. 2d 532, 536 (S.D.N.Y. 2008), *aff'd*, 609 F.3d 87 (2d Cir. 2010)

The three factors weigh in favor of lifting the Litigation Injunction to allow the Receiver to execute on these existing judgments. Regarding the first element, the Receiver will suffer injury if prohibited from pursuing these judgments. The Counterparties owe substantial sums under the relevant Agreements with CBSG, CS2000, or CFS. The Receiver seeks to collect these amounts for the benefit of the Receivership Estate.

Secondly, the timing is appropriate in this instance to lift the Litigation Injunction. While the initial phase of a receivership often involves fact investigation and determining which claims, if any, the Receiver might pursue, the Receiver has now determined that this litigation is necessary to promote the orderly administration of the estate, particularly as it applies to these

Counterparties. Finally, the claims against these Counterparties are meritorious. These Counterparties executed Agreements obligating them to pay CBSG, CS2000, or CFS and are in breach of their obligations thereunder. A proposed Order granting this relief is attached as Exhibit 1.

CONCLUSION

WHEREFORE, the Receiver respectfully requests that the Court enter an Order lifting the Litigation Injunction to allow the Receiver to execute on existing judgments, as he deems appropriate, against the Counterparties under the Agreements, as well as certain of the guarantors under these various Agreements and any collateral and security the Counterparties provided to CBSG, CS2000, or CFS under these Agreements.

CERTIFICATION REGARDING PRE-FILING CONFERENCE

The undersigned counsel has conferred with all counsel of record and unrepresented parties in this matter regarding the relief sought through this motion and certifies that all counsel of record and unrepresented parties have confirmed that they and/or their clients either do not oppose, take no position, or have not responded with their position with respect to the relief sought. The SEC has confirmed that it does not oppose the Receiver's requests to lift the litigation injunction.

**[PROPOSED] ORDER GRANTING RECEIVER, RYAN K. STUMPHAUZER’S
MOTION TO LIFT LITIGATION INJUNCTION AS TO CERTAIN
COUNTERPARTIES IN DEFAULT UNDER AGREEMENTS WITH
COMPLETE BUSINESS SOLUTIONS GROUP, INC., CAPITAL SOURCE 2000, INC.,
OR CONTRACT FINANCING SOLUTIONS, INC.**

THIS CAUSE comes before the Court upon the Receiver, Ryan K. Stumphauzer’s Motion to Lift Litigation Injunction as to Certain Counterparties in Default Under Agreements with Complete Business Solutions Group, Inc. (“CBSG”), Capital Source 2000, Inc. (“CS2000”), or Contract Financing Solutions, Inc. (“CFS”), filed on May 13, 2022 [ECF No. ____] (the “Motion”).

Through this Motion, the Court-Appointed Receiver, Ryan K. Stumphauzer (the “Receiver”) seeks to modify the Court’s Amended Order Appointing Receiver dated August 13, 2020 [ECF No. 141], so as to lift the Litigation Injunction for the limited purpose of allowing the Receiver to execute upon existing judgments against certain counterparties in default under merchant cash advance agreements (the “Agreements”) with CBSG, CS2000, or CFS.
