RECEIVER'S RESPONSE TO J. BRIAN FERGUSON'S MOTION TO INTERVENE AND LIFT THE LITIGATION INJUNCTION

Ryan K. Stumphauzer, Esq., Court-Appointed Receiver (the "Receiver") of the Receivership Entities, through his undersigned counsel, files this Response to J. Brian Ferguson's Motion to Intervene and Lift the Litigation Injunction (the "Motion") [ECF No. 1687] and states:

THE COURT SHOULD DENY THE MOTION WITHOUT PREJUDICE BASED UPON THE AGREEMENT OF THE PARTIES

On August 30, 2023, J. Brian Ferguson, in his capacity as the bankruptcy trustee for the estate of Gregory Houser and Debra Collins-Houser ("Movant"), filed the Motion and requested the Court to modify the Litigation Injunction in the Court's Amended Order Appointing Receiver dated August 13, 2020 [ECF No. 141]. Movant was seeking an order lifting the Litigation Injunction to allow him to pursue certain claims (the "Claims") in a matter pending as case number 5:23-bk-70664 in the United States Bankruptcy Court for the Western District of Arkansas.

Since the filing of the Motion, the Movant and the Receiver have resolved the Claims on terms agreeable to both sides (the "Agreement"). As a term of the Agreement, Movant agreed to forgo continued pursuit of the Motion to afford the parties the opportunity to memorialize and carry out the terms of the Agreement. Under the Agreement, the Movant retains the right to re-file

the Motion at a later date if certain conditions relating to the treatment of secured claims in the Houser's bankruptcy are not satisfied.

As reflected in the email correspondence attached hereto as Exhibit 1, Movant agrees to the denial of the Motion without prejudice.

WHEREFORE, Ryan K. Stumphauzer, as Court-Appointed Receiver, by and through his undersigned counsel, respectfully requests that, based upon the agreement of the parties, this Honorable Court deny J. Brian Ferguson's Motion to Intervene and Lift the Litigation Injunction and enter the proposed order attached as Exhibit 2.
