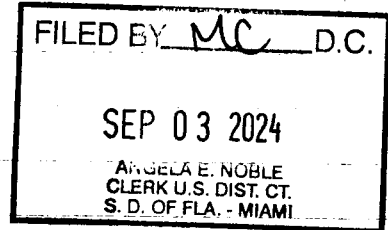


ORDER SETTING BRIEFING SCHEDULE FOR DISTRIBUTION PLAN

ORDERED AND ADJUDGED as follows:

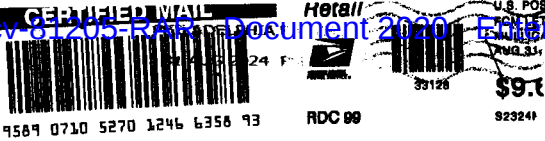
