so that the Receiver and SCIs can continue to attempt to resolve these concerns without the need for further litigation.

As to the SCIs only, the SCIs request that the Court grant an extension of 10-days for the SCIs to respond to the Motion. The Receiver and SCIs have discussed the resulting timeline for pleadings and agree that the following would be applicable:

Deadline for SCIs to respond to Motion: February 6, 2025

Deadline for Receiver to respond to SCIs' pleading: February 17, 2025

WHEREFORE, the SCIs respectfully request this Court grant the SCIs a 10-day extension to respond to the Motion.
